## PRIVACY POLICY FONDAZIONE DIASORIN

## Information Notice according to article 13 of the (EU) Regulation no. 679/2016

Fondazione DiaSorin (hereinafter referred to as the "**Fondazione**") is committed to protect personal data of users (hereinafter referred to as the "**User**(s)") in a lawfully, fairly, transparent and adequate manner, limited to what is necessary in relation to the purposes for which data are processed, pursuant to (EU) Regulation no. 679/2016 related to the protection of personal data (hereinafter referred to as "**GDPR**"), to the Legislative Decree no. 196/2003, as subsequently amended, and the applicable Italian laws.

This Privacy Policy (hereinafter referred to as the "**Policy**") describes the processing of data performed by Fondazione with respect to data collected online at the following link www.fondazionediasorin.it (hereinafter referred to as the "**Website**"), the categories of personal data, the relevant purposes, the retention periods, the legal grounds for processing and the security measures in place to protect the data subjects.

The Policy applies exclusively to the Website and does not cover any other website that may be visited by the Users by means of hyperlinks.

#### **DATA CONTROLLER**

The Data Controller is Fondazione DiaSorin, with its registered offices at Saluggia (Vercelli – Italy), Via Crescentino s.n.c., 13040 hereby represented by its President.

#### **CATEGORIES OF DATA**

Fondazione collects the following categories of personal data provided by the Users on a voluntary basis, such as:

- the contact information (e.g. name, surname, and email address)
- the log-in information (e.g. username and password)
- the professional category of the Users , education, and other similar information

#### **DATA COLLECTION PROCESS**

Fondazione collects personal data (hereinafter referred to as "**Data**") provided by the Users on a voluntary basis on this Website through automated, electronic and paper means, and store data on business database, and electronic platforms directly managed by Fondazione or third parties (duly appointed as data processors).

#### PURPOSES AND LEGAL GROUND FOR PROCESSING

Fondazione uses Data voluntarily provided by the Users in the event that such Users wish to subscribe to the newsletter of Fondazione aimed at promoting cultural and scientific updates and communications. Users may revoke the given consent at any time with no formalities by sending a written notice to the following email address: privacypolicy@fondazionediasorin.it.

The legal ground for data processing may vary according to the specific purpose for which data is collected. As the case may be:

- for complying with the applicable laws and regulation
- for a legitimate interest of Fondazione

• for the subscription of User(s) to the newsletter

The supply of the above Data is optional. Failure to provide the Data may prevent Fondazione from performing certain services in favour of Users (*e.g.* receipt of the newsletter).

#### DISCLOSURE OF PERSONAL DATA TO THIRD PARTIES

Data collected on the Website will not be disseminated nor disclosed to third parties, exception made for the employees of Fondazione, the processors (such as IT providers) and other persons formally in charge of the processing. Data may be disclosed to DiaSorin S.p.A., a company with registered offices at Via Crescentino snc, 13040 Saluggia, (VC), Italy and to DiaSorin's affiliate companies according to article 2359 of the Italian Civil Code (within and outside EU countries), being part of DiaSorin Group.

Your Data may be disclosed to public and judicial authorities where necessary or if required by the applicable laws.

Upon written request, Fondazione may provide a list, that is continously updated, including all data processors in charge at the time of the request.

## **DATA TRANSFER TO EXTRA-EU CONTRIES**

Should Data be communicated or disclosed, upon prior consent of the Users, to DiaSorin S.p.A. or its affiliate companies, their employees, data processors and/or other persons formally in charge of the processing outside the European Union, Fondazione shall inform that all appropriate safeguards and security measures have been implemented to ensure that Data are adequately protected as required by the applicable personal data protection laws and processed according to the content of this Policy.

#### DATA RETENTION AND SECURITY MEASURES

Data will be processed for a maximum time-frame of 10 (ten) years from the date of collection, plus a reasonable period of time to comply with any applicable statute of limitations or if otherwise required under applicable laws or by any public authorities. Adequate security measures have been implemented by Fondazione to prevent losses, unlawfully usage and/or not inappropriate, and unauthorized Data access.

## **DATA SUBJECTS' RIGHTS**

Being a data subject, each User has the following rights: the right of access, to obtain at any time confirmation as to whether or not personal data are being processed and to know the content, existence and source, to verify the accuracy or to request Data to be completed, updated, rectified or restricted.

Moreover, data subjects have the right to require at any time the erasure of Data unlawfully processed, as well as the right to data portability, to object the processing, unless an overriding legitimate ground for processing exists, provided that their existence is demonstrated by the Data Controller for the purpose of continuing their processing. Data subjects may file a complaint with the Italian Data Protection Authority ("Garante Privacy") located in Piazza Venezia 11, 00187, Rome, if they consider that their rights under the GDPR have been infringed as a result of processing activities.
